## More than \$57M Awarded to Help Veterans Overcome Homelessness and Reenter the Workforce

The U.S. Department of Labor has awarded more than \$57 million in grants to organizations that help veterans who are experiencing homelessness find meaningful employment and assist them in overcoming barriers to successfully transition back into the workforce.

"The Homeless Veterans' Reintegration Program grants will fund initiatives that help our veterans – particularly those in underserved communities – get the training and support they need to return to the workforce and use their skills to make valuable contributions to our society," said U.S. Secretary of Labor Marty Walsh.

### First-Ever \$365 Million Funding to Address Unsheltered Homelessness

The Biden Administration through the U.S. Department of Housing and Urban Development (HUD) released a first-of-its-kind package of resources to address unsheltered homelessness and homeless encampments. The \$365 million package includes grant funds along with additional vouchers that will help effectively address unsheltered homelessness by connecting vulnerable individuals and families to housing, health care, and supportive services.

"Getting unsheltered Veterans and homeless rural Vets into houses is a top priority in the Department of Veterans Affairs' strategy to end Veteran

homelessness," said Department of Veterans Affairs Secretary Denis McDonough. "These new resources from HUD add timely new capacity to this fight. No Veteran should ever be homeless in this country, which they swore an oath to defend."

#### **USICH Votes on National Goal to Reduce Homelessness**

The U.S. Interagency Council on Homelessness (USICH) voted to approve an ambitious national goal to significantly reduce homelessness in the next few years and set the United States on a path to end homelessness for all. The goal will be published in the new federal strategic plan, which will be released later this year and will outline strategies and actions for achieving it.

9650: Unconscious Bias: Diversity, Equity, Inclusion, and Accessibility in Veteran Services

NVTI's new 9650: Unconscious Bias: Diversity, Equity, Inclusion, and Accessibility in Veteran Services class was recently piloted at the end of June. Participants enjoyed the flexibility of participating virtually and found that the one-day session was packed with meaningful information applicable to their immediate jobs and responsibilities. Participants enjoyed the new informative

curriculum, the freshness of having two instructors in one class, and reported a 90% satisfaction rate with the instructors' knowledge of the topic.

From this class, you can gain new insights and perspectives about bias that will be useful in reconciling values, attitudes, and behaviors associated with a broader diversity and inclusion conversation as well as broaden your appreciation for the nuances and relationship of DEIA, organizational culture, and unconscious bias in their impact on our decision-making as veteran service providers.
