

### New U.S. Department of Veterans Affairs (VA) Mission Statement

The VA has updated its 1959 mission statement to the following: "To fulfill President Lincoln's promise to care for those who have served in our nation's military and for their families, caregivers, and survivors." The new mission statement removed the male pronouns and replaced them with non-gendered pronouns. "We are here to serve all Veterans, their families, caregivers and survivors — and now, our mission statement reflects exactly that," said VA Secretary Denis McDonough.

## \$1 Billion Reached in Grants for the National Cemetery Administration

The <u>National Cemetery Administration (NCA)</u> has reached \$1 billion dollars in grants to states, U.S. territories, and tribes for the establishment, expansion, improvement, and maintenance of state, territorial, and tribal veterans cemeteries.

Thanks to these grants, the NCA covers the cost of the gravesite, the grave liner, the opening and closing of the grave, the government headstone or marker, the U.S. burial flag, the Presidential Memorial Certificate, and perpetual care of the gravesite. The veteran's immediate family members may also be eligible for burial.



#### **More Affordable Housing for Native American Veterans**

The VA recently announced it was reducing the interest rate for <u>VA Native American</u> <u>Direct Loans</u> from 6 percent to 2.5 percent, making housing loans more affordable for Native American veterans. Through this program, the VA provides direct loans to Native American veterans as well as veterans who are married to Native Americans who are not veterans in order to help buy, build, or improve a home on trust land, providing limited closing costs without the need for a down payment or monthly mortgage-insurance costs.



### \$16 Billion in VA Benefits Compensation in 2022

In 2022, veterans and other claimants represented by the American Legion received over \$16 billion in VA benefits compensation. In addition, the Legion's Board of

Veterans' Appeals Unit represented more than 17,000 appellants, helping them to secure more than \$66 million in retroactive VA claims benefits.



### **New Phishing Scam Targeting Veterans**

The Better Business Bureau discovered a phishing scam targeting veterans and their families. You receive an email or phone call informing you that you qualify for compensation for the Camp Lejeune class action lawsuit, which sought damages on behalf of individuals who were harmed by contaminated Camp Lejeune water, following exposure at the marine base for at least 30 days between August 1, 1953, and December 31, 1987.

From here, whether by phone or computer, the scam takes several different forms. Clicking the email link could automatically download malware onto your computer or mobile device, putting you at risk for identity theft. Alternatively, the scammers may direct you to a website that asks you to fill out personal information. In yet another version of the scam, the scammers claim you need to pay an upfront fee to file your case and receive your compensation. They will continue to ask for filing fees until you become suspicious, at which point, they will disappear with your personal information and money.

## **SUCCESS STORY**



The following is a Homeless Veterans' Reintegration Program (HVRP) success story of a veteran told from the grantee's perspective. The name of the veteran has been changed to protect their identity.

# An Employment Specialist Who Listens to the Veteran's Needs Can Make all the Difference

When Thomas enrolled in HVRP in June of 2022, he had just been involuntarily exited from a housing program with nowhere to go. He had little hope of successfully completing another program. He was living out of his inoperable van for several weeks until another service provider placed him in a hotel for a few weeks. A pending criminal charge and marital separation contributed to the loss of his job and homelessness. During his initial conversation with his Employment Specialist, he was very vocal and expressed a lot of frustration and disappointment in his life, but his Employment Specialist was a compassionate person and a good listener, which allowed Thomas to trust them and establish a rapport. Several days following the intake, Thomas received a job offer from Amazon, and with the assistance of the service provider, he moved into his own apartment on July 8, 2022.
