  - Recipient Information: Learn and understand the programmatic, administrative, and managerial requirements of VETS' HVRP
  - Policies and Requirements: DOL/VETS requirements and policies that affect HVRP
  - Training and Assistance: Information on training and technical assistance services available to HVRP grant recipients
  - Resources: Applicable resources, guides, desk aids, and more related to HVRP
  - Program Documents: Templates and forms related to HVRP

#### Day 1 Resources: VETS Systems



- Payment Management System (PMS): Provides grant recipients with cash management services, centralized payment services, personal grant accounting support, and Financial Reporting Support
- VETS Grantee Reporting System (VGRS): System for collecting, managing, and reporting program data. All VETS HVRP grant recipients must use VGRS to complete their quarterly performance requirements
- GrantSolutions: Official grants management system for DOL supporting the activities and correspondence needs during the lifecycle of a grant — from pre-award planning through application, award, and closeout

# Day 1 Resources: Training and Technical Assistance



- NVTAC: Contracted by DOL/VETS to provide technical assistance and training opportunities specifically for HVRP staff
- NVTI: Contracted by DOL/VETS to provide professional instruction and coursework for Jobs for Veterans State Grants (JVSG), DOL/VETS federal staff, and other veteran service providers (VSP) including HVRPs
